Lacks Foundation (Evid. Code § 403). 2. Lacks Personal Knowledge (Evid. Code § 702). 3. Improper Opinion Testimony (Evid. Code §§ 800-803). Ms. Bekele fails to lay a foundation as to the source of her knowledge, or demonstrate personal knowledge, of the statement that ICANN would favor ZACR throughout the application process. Further, because it is not rationally based on her perception, this statement amounts to inadmissible opinion testimony. It also amounts to speculation inasmuch as Ms. Bekele does not provide any other information to support her statement.		Sustained Overruled
